**POLL RESULTS OF ANNUAL GENERAL MEETING  
HELD ON 15 MAY 2020  
AND  
PAYMENT OF FINAL DIVIDEND FOR THE YEAR ENDED  
31 DECEMBER 2019**

At the annual general meeting (the “AGM”) of Times China Holdings Limited (the “**Company**”) held on 15 May 2020, a poll was demanded by the chairman of the AGM for voting on all the proposed resolutions as set out in the notice of the AGM dated 8 April 2020 (the “**AGM Notice**”).

As at the date of the AGM, a total of 1,941,817,142 shares of the Company (the “**Shares**”) were in issue and the holders of which are entitled to attend and vote for or against the resolutions proposed at the AGM. There were no restrictions on any shareholders of the Company (the “**Shareholders**”) casting vote on any of the proposed resolutions at the AGM. None of the Shareholders have stated their intention in the circular of the Company dated 8 April 2020 to vote against or abstain from voting on any of the proposed resolutions at the AGM.

The Company’s share registrar in Hong Kong, Computershare Hong Kong Investor Services Limited, acted as the scrutineer at the AGM for the purpose of vote-taking. All the resolutions were approved by Shareholders by way of poll. The poll results in respect of the respective resolutions proposed at the AGM were as follow:

### **Further information on the payment of final dividend**

The proposed final dividend of RMB84.45 cents per Share for the year ended 31 December 2019 has been approved by the Shareholders at the AGM. The register of members of the Company will be closed from Thursday, 21 May 2020 to Monday, 25 May 2020, both days inclusive, during which period no share transfers will be registered. All transfers of Shares accompanied by the relevant share certificates and transfer forms must be lodged with the Company's share registrar in Hong Kong, Computershare Hong Kong Investor Services Limited, at Shops 1712–1716, 17th Floor, Hopewell Centre, 183 Queen's Road East, Wanchai, Hong Kong no later than 4:30 p.m. on Wednesday, 20 May 2020. The dividend is expected to be paid on 2 July 2020 to those Shareholders whose names appear on the register of members of the Company on Monday, 25 May 2020.

The final dividend payable to Shareholders shall be converted to and paid in Hong Kong dollars based on the average exchange rate of Hong Kong dollars against Renminbi announced by the People's Bank of China on 15 May 2020, being HK\$1.00 to RMB0.91507. Based on the above exchange rate, the amount of final dividend payable shall be 92.29 HK cents per Share.
